Subject to a favourable report, the applicant will be proposed and seconded by two committee members.

The annual subscription is due on 1<sup>st</sup> August each year & payable within 28 days. Any member whose subscription remains unpaid at the date of any MVDA AGM is not allowed to take part in or vote at that meeting. In the event of non-payment of subscriptions within 3 months of the AGM, the Executive Committee shall have the power to cancel membership

False declarations made to obtain membership may result in the cancellation of membership. In such cases the MVDA reserves the right to retain any entrance fee or subscription paid.
